Entry of Foreigners during the Extraordinary Situation

From 6 April 2022, the Decree of the Public Health Authority of the Slovak Republic No. 28/2022 regulating the regime at the borders is repealed. Thus, the obligation to register on eHranica as well as the mandatory quarantine for unvaccinated persons immediately after the arrival from abroad are abolished. However, it is still recommended to be cautious, to monitor your health condition and to contact your general practitioner or pediatrician in case of Covid-19 symptoms.

If you have questions concerning the border regime, please contact the <u>Ministry of Interior of</u> <u>the Slovak Republic</u> or the Bureau of Border and Foreign Police of the Presidium of the Police Force of the Slovak Republic (<u>suhcp@minv.sk</u>). The information on conditions of entry of foreigners during the extraordinary situation is published at the <u>website of the Ministry of</u> <u>Interior of the Slovak Republic</u>.

Requests for information on issuance of visas for entry to the Slovak Republic should be addressed directly to the respective embassy or consulate general of the Slovak Republic.

Ministry of Foreign and European Affairs cautions all citizens of the Slovak Republic that when returning to Slovakia they take into account possible delays at border crossing points due to preventative measures adopted due to the spread of the coronavirus in Europe.
