## NOTICE:

- 1. Mr. Dong-Moon Joo (American name: Douglas D. M. Joo), who was a director and a representative trustee of both Korean Times Aviation LLC and Washington Times Aviation USA LLC (from here on "WTA"), was legally discharged (refer to attached document no. 1 and 3) from both positions on October 28, 2009. Immediately after receiving his notice of discharge (notice of discharge received on November 8, 2009, refer to attached document no. 2), on November 9, 2009, through his secretary and driver Sung-Jin An, he withdrew (1) 7 million US dollars (account number 595-85-003942), (2) 7,953,000,000 Korean Won and 3,690,000,000 Korean Won (account number 595-20-163024), and (3) 4,357,000,000 Korean Won (account number 171-20-013360) from 3 bank accounts owned by WTA at the Standard Charter First Bank of Korea, Kimpo New City bank branch and transferred the funds to your Foundation's account (account number: 20703448604011) at the Industrial Bank of Korea, Suk-Soo Station branch.
- 2. However, the above mentioned actions of Mr. Dong-Moon Joo were done regardless [of the fact] that he was no longer the legitimate director and representative trustee; without any legal basis he illegally took out the funds of the company WTA.
- 3. Because the funds received from WTA on Nov. 9, 2009, have to be returned to WTA, the above mentioned funds cannot be withdrawn or transferred abroad without the consent of WTA and we ask that all the necessary actions for its return be quickly taken.
