* The "58th Transition of the Three Ages Four Position Foundation Registration Unification Blessing Ceremony" will be held from November 29 (Fri) to December 1 (Sun). So First receive the Registration Blessing with your wife and children, and then attend the 8-day workshop for blessed husbands.

2) Eligible Participants: Blessed Husbands who have not yet participated in the Special 8-day Workshop for Worldwide Registered Blessed Husbands

3) Location: Cheongpyeong Heaven and Earth Training Center

4) Workshop fee: \$500 US (You may pay the fee in Won, but it is preferred that it be paid in US \$)

True Parents of Heaven, Earth and Humankind extended to all blessed families the grace of removing the original sin through the "Marriage Blessing" (church level blessing), so that each family, after that, could complete the four position foundation and be entered on True Parents' register through the "Four Position Foundation Registration Blessing" (national level blessing). Previously, through the "Holy Marriage Blessing Ceremony of the Parents of Heaven and Earth, Opening Cheon II Guk" (solar: Jan.6, 2003) and the "10.14 True Parents' Cosmic Blessing" and "Cosmic Blessing," and completed the ideal of the blessing through their holding the "Cheon II Guk Foundation Day Registration Blessing Ceremony" (1.13 by the heavenly calendar, 1st year of Cheon II Guk). 1. The 58th 21-day Registration Workshop for Blessed Wives

1) **Schedule** -10.7 to 10.27 by the heavenly calendar, 1^{st} Year of Cheon II Guk

<u>: November 9 (Sat, 7 p.m.) – 29 (Fri, 12 p.m.), 2013</u>

*If you are able to register until November 14 (Thursday), you are eligible to attend 58th Registration Blessing Ceremony. However, you must attend 21 days not including the period of 2-night and 3-day Registration Blessing workshop.

2) Eligible Participants:

1 Blessed wives who have not participated yet in the Registration Workshop for Blessed wives

② Blessed wives of the Spirit World and Physical World Blessed Family

* However, if you are an old or feeble person, your daughter, daughter-in-law or spiritual daughter can represent you.

3) Location: Cheongpyeong Heaven and Earth Training Center

4) Workshop fee: \$1,000.US

5) **Hoondok Materials**: Exposition of the Divine Principle (3-colored version), Pyeong Hwa Hoon Gyeong, As a Peace-Loving Global Citizen

6) **Materials to Prepare**: A set of dress clothes, white t-shirts (three or more), umbrella and raingear, toiletries, donation of gratitude, FM radio, personal medication, medical insurance certificate, etc.

7) Points to Consider:

① Children are not permitted to attend this workshop. Please do not bring them along. (If the situation is difficult and you want to bring your child, first contact the International office.)

(2) Members who are psychologically or spiritually challenged must first consult with Rev. Kim (+82-31-589-7188). If permission is granted, he or she may only register if accompanied



by a caregiver. (Please keep in mind that if permission is not granted, or if a caregiver does not come, such members may be asked to return home.)

③ Pregnant sisters are encouraged to attend during the 5th to 6th months of pregnancy for safety reasons. (There is concern that coming too early or too late may increase the chance of a miscarriage or premature delivery.)

(4) A caretaker must accompany those who are weak from sickness or age.

2. The 58th Transition of the Three Ages Four Position Foundation Registration Unification Blessing Ceremony

1) Schedule -10.27 to 29 by the heavenly calendar, 1^{st} Year of Cheon II Guk

58th: November 29 (Friday, 7 p.m.) – December 1 (Sunday, noon), 2013

2) Participants:

① Those who have not participated in the Registration Blessing Ceremony

(2) 2nd and 3rd generation children who have not participated in the Holy Wine Ceremony because they were born after their parents attended the Registration Blessing Ceremony

3) Place: Cheongpyeong Heaven and Earth Training Center

4) Workshop Fee:

Adults (over 13 yrs)	35,000 won
Children (3~12 yrs)	25,000 won
Babies (0~2 yrs)	10,000 won

5) **Materials to Prepare**: Holy Robes (blessing ring and white socks and white gloves), white t-shirts, clean white top (white t-shirt) for children without Holy Robes, donation of gratitude, FM radio, etc.

6) Points to Consider

① If circumstances prevent a child(ren) from attending the ceremony, it is possible to bring a picture of the child(ren) and participate as their representative. However, the child(ren) must be sure to come to Cheongpyeong and participate in the next Registration Blessing Ceremony and drink the holy wine.

O In the case that a husband, wife or child has passed away, the family must bring their picture and participate in the Registration Blessing Ceremony on their behalf.

3 When those children (2nd or 3rd generation children) who have not received yet the Registration Blessing attend the Registration Blessing workshop, if your children are in



elementary school and below, the parent(s) can register on the second day of the Registration Workshop, Saturday (attend 1-night and 2-day workshop), however, if your children are in junior high school or over, the children need to attend the entire Registration Blessing Workshop (2-night and 3-day workshop). (Participants must wear Holy Robes)

④ The Spirit World and Physical World Blessed Family members should prepare your holy robes (You do not need to bring the spirit's photo and holy robes). However, if your representative attends, your representative should prepare his or her own holy robes. After attending the blessing ceremony, your representative must take back the holy wine from the Korean Office and let the person of the Spirit World and Physical World Blessed Family drink the holy wine.

(5) The husband and wife, and the children can attend the Registration Blessing Ceremony only if the wife completed the 21-day Registration Workshop.

1) Even if you obtain traveler's insurance, you will be asked to pay the hospital fee first, and then get reimbursed later. Please prepare extra cash for emergency medical expenses.

The Cheongpyeong 40-day Workshop, as an important workshop for inheriting True Parents' victorious realm and completing the three great blessings, was started from March 12, 1996 based on True Parents' words, and now the 178th Cheongpyeong 40-day workshop is being held in the midst of grace. The Cheongpyeong 40-day Workshop will be held for the purpose of double-checking one's faith, making a new start and solving individual and family problems.

Regarding the Cheongpyeong 40-day Special Workshop for Blessed Wives, True Father said; <u>"There is no way to resolve all the wrong things that you have done after receiving the Blessing without reporting them. 2) Participants: Members (middle school age and over), and blessed wives who have not yet participated

- Members who want to attend the 40-day Workshop for Blessed wives can come during these same time periods.

- If a Blessed wife has passed away, her husband, physical children, or spiritual children can participate in the 40-day Special Workshop for Blessed wives, as her representative.

2. Hoondok Materials: 3-colored *Exposition of the Divine Principle*, *Pyeong Hwa Shin Gyeong*, *As a Peace-Loving Global Citizen*

3. Materials to Prepare: Holy Song book, shoe bag, umbrella, toiletries, white t-shirts (three or more), thin pants for Chanyang Yeoksa Sessions (Holy Song Sessions), comfortable shoes and sports wear, **a set of dress clothes**, Holy Robes and Blessing Ring (for those who will participate in the Ancestor Blessing Ceremony), one photo (3x4 cm), personal medication, medical insurance (for those who will use the services of CheongShim International Medical Center, see the next page), FM radio, and some warm clothing. **During 40-day workshop, the use of cellular phones and smart phones, MP3 player and tablet PCs are not allowed.**

6. Points to Consider:

1) Please register at the International Office by 6 p.m. on the starting day of the workshop (November 9, Saturday).

2) Parents may not bring young children (elementary school age and below) with them to attend the 40-day Workshop. However, if it is the case that the children in 5^{th} grade or above accompanied by a parent, you may do registration after consulting with the International Office.

3) Please prepare thin pants that will not release lint and dust during Chanyang Yeoksa Sessions.

4) Members who are psychologically or spiritually challenged must first either consult with the psychiatric department of the CheongShim International Medical Center, or consult with Rev. Kim (+82-31-589-7188). If permission is granted, he or she may register only if accompanied by a caregiver. (Please keep in mind that if permission is not granted, or if a caregiver does not come, the member may be asked to return home.)

5) Medical Insurance for Traveling Abroad (Traveler's Insurance)

① Even if you obtain a traveler's insurance, you will be asked to pay the hospital fee first, and then get reimbursed later. Please prepare extra cash for emergency medical expenses.

② If you have appropriate insurance, you can receive medical treatment without paying the whole payment, by paying the required deduction amount plus your percentage of the total subsequent costs according to the contract you made with the company. But please check all details with the company as to whether or not it can be used in South Korea.

6) Members coming to Korea from abroad **must obtain a 90-day visa, before coming to the workshop**. The Training Center cannot acquire or extend visas for you. If your visa expires while you are in Korea, the immigration office will charge you a penalty of \$100 US per month and your name will be placed on a list.

7) In order to protect Cheongpyeong Lake from pollution, and for the protection of the environment, the use of any shampoo, rinse and body shampoo is strongly discouraged, except for soaps and, for laundry time, the liquid detergent selling at the training center is strongly encouraged.

7. Information concerning those pregnant sisters who are attending 40-day workshops

1) Due to the termination of its' operation in the obstetrics and gynecology department and the delivery room, the outpatient clinic only will be open as of March 24, 2013. (The prebirth education for 40-day workshop members will continue to be carried out.)

2) All medical treatments, including miscarriage, premature delivery (premature contraction), other than delivery will be carried out as before.

3) Qualifications to be admitted as pregnant sister: Pregnant sister who enter their stable period (5 months after the pregnancy), and complete their workshop within the periods noted.

<u>(1) Members living in Korea: Pregnant sisters who complete their workshop 15 days</u> before their due date.

(2) Members from overseas: Pregnant sisters who complete their workshop before 31 weeks of pregnancy (You are allowed to board a flight until 31 weeks of pregnancy. You will need a medical document issued by a doctor if you are between 32 and 37 weeks of pregnancy, and it will be impossible to board a plane after 38 weeks of pregnancy. However, if you intend to give birth in Korea, then you can be admitted under the standard of **Members living in Korea** category).

4) Grace of receiving a name for your child from Dae Mo Nim

(1) If you gave birth at the CheongShim International Medical Center, Dae Mo Nim has so far been giving a name for your child. However, from now on, there will be the grace of receiving a name for your child from Dae Mo Nim if you send a naming application form to the Training Center after the birth of your child, after attending a 40-day Workshop as a Pregnant Sister.

2 The application form will be given to the pregnant sisters individually while they are attending the 40-day workshop, and further contents regarding this will be announced during the workshop.

8. The 181st Cheongpyeong 40-day Workshop and the 92nd 40-day Workshop for Blessed wives will be held 11. 19 – 12. 29 by the Heavenly Calendar (December 21, 2013 – January 29, 2014).
