Those presented here have been selected as particularly pertinent to the overarching theme of the event by human rights specialists drawn from among UPF's and WFWP's 'Ambassadors for Peace' network. The spirit of The U.N.'s Universal Declaration of Human Rights resonates very strongly with UPF's and WFWP's sense of the sacred value of humanity and with their vision of humankind as 'One Family under God'.

After international arrivals on June 14th the conference programme will convene on June 15th in the Houses of Parliament with speakers including Baroness Sandip Verma (UK government spokesperson for Business, Innovation and Skills), Willy Fautré (Human Rights Without Frontiers International), Keith Best (C.E.O. Freedom from Torture), Imam Dr Abduljalil Sajid and hosted by UPF- UK Patron, Lord King of West Bromwich. The second day of the programme, June 16th will take place at the Royal National Hotel on Russell Square and will explore insights into education for human rights and dignity.

A fee of 320 Euros for each participant will include two nights stay in a twin – bedded room in the Royal National Hotel, Russell Square, with meals, transport and all aspects of the programme. Partial List of Biographies:

Keith Best, the CEO of Torture Care, said "Torture is no respecter of class, status or achievement. I met people who have been deeply traumatised by the experience of torture – they bear the scars both physically and mentally." He has spent 20 years in the voluntary sector, advocating for the rights of people on the margins of society. He initially worked for NCH Action for Children, as director of Prisoners Abroad, and most recently as chief executive of the Immigration Advisory Service for the past 16 years. Best was named in Society Guardian as one of the 100 most influential people in public services in the UK.

Rev. Dr. Marcus Braybrooke is a retired Anglican parish priest who has been involved in interfaith work for over forty years, especially through the World Congress of Faiths, which he joined in 1964 and of which he is now President. He was Executive Director of the Council of Christians and Jews from 1984-8. He is a Co-Founder of the Three Faiths Forum, Patron of the International Interfaith Centre at Oxford and a Peace Councillor. He has travelled widely to attend interfaith conferences and to lecture. He has studied for a time in India and in Israel. In September 2004, he was awarded a Lambeth Doctorate of Divinity by the Archbishop of Canterbury 'in recognition of his contribution to the development of inter-religious co-operation and understanding throughout the world.' He is author of over forty books on world religions and Christianity. Marcus is married to Mary, who is a social worker and a magistrate. They have a son and a daughter and six granddaughters. Together with UPF he has coordinated a series of conferences on the topic of 'Forgiveness and Reconciliation'.

Willy Fautré is the Director of Human Rights Without Frontiers International. He was a Consultant for INSPAD, Institute for Peace and Development in Brussels (2006); 1995 - 1996: Director of the Phare Democracy Programme (European Commission Project) "Religious Minorities in Albania, Bulgaria and Romania"; Mission at the Belgian Parliament (1989 -1990); Mission at the Cabinet of the Belgium Ministry of Education (1984 -1985); He is a frequent commentator and author on religious freedom and human rights issues around the world.

Carolyn Handschin is a Vice President of WFWP International and President of WFWPI in Europe, Deputy Director of the WFWPI Office for United Nations Relations and its Permanent Representative to the UN in Geneva since 1997. Coordinator of the UN Office of UPF in Geneva and contributing to the work of the Human Rights Council (was Commission) since 1994, in the areas of peace-building, leadership and governance, women's human rights and their empowerment, education for peace and fulfilling the MDG's. Until recently in 2011, Secretary of the UN NGO Committee on the Status of Women and remains a member of the Committee, as well as the Working Groups on "Peace", and "Human Rights Education and Learning" at the United Nations in Geneva. She contributed to the NGO task forces on "Disarmament" and "Culture of Peace", the latter of which she chaired. She is a Founding member of the Fribourg Peace Forum in Switzerland and Co-founder/Vice-President of the Geneva Interfaith and Intercultural Alliance (GIIA) currently coordinating its "Youth Interreligious Council" Model-UN program.

Lord King of West Bromwich (UPF-UK Patron) served as Councillor of Sandwell Metropolitan Borough Council from 1979 to 2007. He was a Deputy Mayor from 1982 to 1983. He was created a life peer in 1999 as Baron King of West Bromwich, in the County of West Midlands. From 1999 to 2003 he belonged to the committee *Member Hybrid Instruments*. Since 2006 he is Treasurer of the India Group.

Imam Dr Abduljalil Sajid JP is a Muslim scholar, thinker, speaker, educator and mentor. A British Muslim of Pakistani origin, he is at present Chairman of a number of organisations including the Muslim Council for Religious and Racial Harmony UK, the National Association of British Pakistanis and the UK Chapter of the World Conference of Religion and Peace. He is also a consultant to a number of statutory and voluntary agencies on race, multi-cultural and religious issues. Imam Sajid is the founding member of Alif-Aleph UK British Muslims-British Jews and the Standing Conference of Jews, Christian and Muslims in Europe (JCM). He is Imam of the Brighton Islamic Mission.

Prof. Siddharth Saxena (Montu) is Chairperson of the Cambridge Central Asia Forum, Director of Cambridge Kazakhstan Centre and Honorary Secretary of the Committee for Central and Inner Asia. He trained as an anthropologist, historian and a physicist. His research interests are in the areas of religion and identity, knowledge systems, social and political development and institutional history in Central Asia and the Middle East. In Physics he works on science of strongly correlated electrons, superconductivity and magnetism. He is a Fellow of Jesus College at the University of Cambridge.

Madi Sharma is the founder of the "Madi Group" - Make A Difference Ideas group of International Private and Social Enterprises UK Member, Employers Group, European Economic and Social Committee. Madi is a businesswoman who currently runs the Madi Group, a group of private sector and not for profit companies with a philosophy to create innovative ideas tailored to local action which can achieve global impacts beneficial to society. Madi is a public speaker, particularly in the field of entrepreneurship, diversity and gender balance where she presents and teaches in schools and to forward thinking organisations. The experience was gained when Madi began her first company from her kitchen at home, which grew to 2 factories and 35 staff, for which see received the honours of Asian Woman of Achievement and UK's Best Boss. Additionally Madi is a Nottingham Ambassador and an East Midlands Business Champion, as well as a member of the Employers Group of The European Economic and Social Committee in Brussels, a European Consultative Institution for civil society.

Dr Yong Cheon Song is Regional Director for The Universal Peace Federation in Europe and European President of the Family Federation with overall responsibility for the activities of the Unification Movement in 36 nations of Europe since 2003. Previously he worked extensively in senior roles for UPF and allied organisations in Kenya, Australia, New Zealand, The Solomon Islands and Oceania. He was awarded a doctorate in theology by Sun Moon University, South Korea in 2005.

Baroness Sandip Verma was born in Amritsar in Punjab, India on 1959. She moved as child with her parents to England in 1960. She is a British businesswoman and currently <u>a Government Whip</u> and Spokesperson for the Cabinet Office, International Development and Equalities and Women's Issues in the House of Lords. In 2006 Baroness Verma was made a Patron of the Tory Reform Group. She was created a <u>Conservative life peer</u> as Baroness Verma, of Leicester in the County of <u>Leicestershire</u> in May 2006, having been an unsuccessful parliamentary candidate in two <u>general elections</u> (2001 and 2005). Since 1977, Lady Verma has been married to Ashok Verma. They have a daughter and a son.

Peter Zoehrer is Chief Editor & Secretary General of FOREF Europe (Forum for Religious Freedom – Europe, President: Prof. Dr. Christian Bruenner, renown human rights- & constitutional expert). During the past 12 years FOREF scored over 30 victories in helping victims of religious intolerance to regain their rights, and gain vindication from injustice, discrimination or persecution. Also Director of UPF –UN office in Vienna, a Member of the Austrian Journalist Association (National Press Club) and President of Family Federation for World Peace – Austria.

Lord Nazir Ahmed of Rotherham was the first Muslim peer at the House of Lords. Later, he went on to build a career as a business development manager while keeping actively involved in his local community. He was a local councillor during the 1990s, as well as serving as a JP on the magistrates' bench, chairing the South Yorkshire Labour Party for four years and acting as a non-executive Director of Rotherham Health Authority. He was raised to the peerage as Baron Ahmed, of Rotherham in the County of South Yorkshire in 1998. As a high-profile leader of the Muslim community, Lord Ahmed has played a role in easing tensions after the London bombings in July 2005 and the 9/11 attacks on the US in 2001. He helps with various charitable causes and is on the board of several organisations. He is president of South Yorkshire Victim Support and a trustee of the British Heart Foundation. The Home Office tapped into his skills when it enlisted him to write a joint report on the issue of forced marriages. He has been very active in international issues involving the Muslim community.
