**Re.: Additional Registration Period for the 2021 Cheonbo Evaluation and Readjusted
Administrative Details**

May the love and blessings of Heavenly Parent and True Parents be with you always.

Through the grace of True Parents, we are happy to announce that registration period for Cheonbo evaluation has been further extended, and we hope this will give many more blessed couples the opportunity to register as Cheonbo couples this year. Accordingly, the evaluation schedule and administrative details for the Cheonbo registration have been readjusted. We would be grateful if you can notify all Cheonbo candidates about these readjustments.

1. Additional Registration for Evaluation

A. Extended period of registration: August 9 – September 30, 2021

B. Application Guidelines

- 1) The following are essential information for the production of the items to be bequeathed to Cheonbo couples. Candidates are therefore asked to pay special attention to accuracy.
- 2) Entering your name on the website:
 - The candidate's name must be accurately entered on the website as the name on the website will be imprinted on the Cheonbo Plaque, the Cheonbo Card, etc.
 - On the 'Family Name' section, please enter only the family name. The same goes with the 'Given Name' section.
 - Candidates should enter the name by which they wish to be registered.
 - Symbols such as parentheses, etc., are not permitted when entering your name.
- 3) Entering measurements on the website:
 - Please enter your chest size and height in *centimeters*. These measurements will be used in making your Cheonbo Holy Robe.
 - For height, measure from the top point of your head to the sole of your foot. Your feet should be bare when making this measurement.
 - For chest size, please enter the full 360-degree circumference of your chest.
- 4) Uploading your photo
 - For evaluation, a candidate couple can upload a regular photo of themselves, but we recommend preparing a photo that meets the standard requirement mentioned below for the Cheonbo exhibition and Cheonbo card that will come later.
 - Standard requirements for a Cheonbo candidate's photo:

- Upload a photo of the candidate couple. It is permitted to upload an individual photo in special cases.
- If possible, we recommend having your photograph taken by a professional photographer.
- Image quality: At least 5,000 pixels in height and 3,000 pixels in width (300 dpi)
- Photo background: we recommend a one-color background
- Posture: A photo of the couple standing with their full bodies in view. In case of a tremendous difference in height between the husband and wife, one spouse can take the photo seated.

B. Adherence to the schedule.

- 1) Additional candidates must create a new account on the evaluation website within the additional registration period
- 2) The church pastor of the candidate couple should decide, and make his or her recommendation within the designated time period for recommendation.
- 3) A candidate uploads all the required documents for evaluation within the designated period and applies for evaluation.
- 4) 1st level and 2nd level evaluation committee members will conduct and conclude evaluation of candidates within the designated additional period of evaluation.
- 5) To those candidates who pass the 2nd level evaluation by August 18 (Korean Standard Time), we will be sending their bequeathed Cheonbo items [Cheonbo Award Box] prior to the Cheonbo Entrance Ceremony. In the case the prepared Cheonbo Award Boxes and items fall short in number, priority for delivery will be placed on candidates who have paid the Blessing donation in full. The additional victors will be announced together with all those being registered (inducted) in October.
- 6) For the remaining candidates, the 1st and 2nd level evaluation will be conducted in September, and those being registered as Cheonbo will be announced in October as mentioned above. The Cheonbo Award Box for these candidates will be delivered after the Cheonbo Entrance Ceremony.

3. Specifications to do with the Documentation for the Evaluation of Ancestor Blessing

- A. In the case of candidates submitting a certificate of completion of the Blessing of 430 generations of ancestors: Only a certificate of completion issued from the HJ Cheonbo Training Center website homepage that certifies the completion of Ancestor Blessing for all eight lines is valid.
- B. In the case of candidates submitting records showing they have completed 430 generations of ancestor Blessing:

- 1) Only such a record that has been issued from the HJ Cheonbo Training Center website on or after August 4, 2021 is valid.
 - 2) In the case of a couple candidate, the record must show the completion of Ancestor Blessing for all four lines of ancestors of the husband's side, as well as for all four lines of the wife's side. For cases other than couple candidates, the basic requirement per individual candidate is the record of having completed 4 lines.
 - 3) In the case that a candidate has completed the Blessing of all 430 generation of ancestors, but has not paid in full the required donation: The candidate couple must submit their record of Ancestor Blessing issued by the HJ Cheonbo Training Center as well as their completed and signed "Agreement to Complete the Blessing of Ancestors" [accompanying this memo as an attachment] to their regional headquarters (in the case of Korea, to their subregional headquarters). The regional president is to then issue a certificate confirming the candidate's agreement. Once that is done, the candidate is to upload this certificate of confirmation to the website.
- C. In the case of candidates submitting records of having completed the liberation of 430 generations of ancestors:
- 1) Only such a record that has been issued from the HJ Cheonbo Training Center website on or after August 4, 2021 is valid.
 - 2) The candidate must submit their record of Ancestor Liberation issued by the HJ Cheonbo Training Center as well as their completed and signed "Agreement to Complete the Blessing of Ancestors" to their regional headquarters. The regional president is to then issue a certificate confirming the candidate's agreement. Once that is done, the candidate is to upload this certificate of confirmation to the website.
 - 3) In the case of a couple candidate, the record must show the completion of Ancestor Liberation for all four lines of ancestors on the husband's side, as well as all four lines on the wife's side. For cases other than couple candidates, the basic requirement per individual candidate is the record of having completed 4 lines.
 - 4) A candidate that has not paid the required ancestor liberation donations in full may not request a confirmation certificate.
