Following the first level of CheonBo evaluation conducted in August 2021, the second level of CheonBo evaluation is underway. However, after this upcoming CheonBo Festival on October 10th, **the next CheonBo Festival will be conducted in the year 2027**, so we are announcing the 2nd adjustment of CheonBo evaluation period as below according to the True Parents' grace providing more opportunities for more candidates to apply for CheonBo this year. 1. Notice of 2nd Adjustment of CheonBo 2021 Evaluation Period

A. Period: By October 9th (Saturday), 2021

B. Administrative Matters

- 1) The candidate must prepare the supporting documents within the period and "Request Evaluation"
- 2) The Church Leader of the church to which the candidate belongs must complete the "Recommendation by Church Leader"
- 3) We will conduct the 1st level evaluation and 2nd level evaluation from time to time within the period.

C. Notice for Candidates

- 1) The candidates who are in the process of evaluation and the candidates who are requesting for the evaluation within the period must attend the "CheonBo Holy Wine Ceremony" that will be held by each region before October 3rd.
- 2) The candidates who are in the process of evaluation and the candidates who are requesting for the evaluation within the period must attend the "CheonBo Registration Blessing" on October 3rd that is conducted by the International Headquarters.
- 3) The candidates who are in the process of evaluation and the candidates who are requesting for the evaluation within the period must attend the "CheonBo Festival" on October 10th that is conducted by the International Headquarters.
- 4) The schedule of the final evaluation and the announcement of the induction result will be informed later on.
