C. the daughter of Ernest and Keiko Patton, who are loving parents and leaders of our movement. In early 2017 after a Gardasil vaccination and in combination with Lyme disease, their precious daughter developed crippling arthritis. In July 2017, she could not walk or even feed herself. Today she is walking, using the computer and, recently, feeding herself. There is still have a long way to go before complete healing.

Child Protective Services in Arlington, Virginia are currently trying to force the Pattons to use chemotherapy to "heal" their child, in spite of the family's deep concerns for the dangerous side effects. The Patton's have lawyers working to protect their rights as a family to choose medical treatment for their daughter. Currently, they are taking C. to certified doctors who have been treating her with a more natural regiment that does not carry severe side effects. Their insurance company will not cover these treatments. Any contribution to help them pay the mounting legal and medical costs will be gratefully received.
