The requester failed to provide a notarized authorization from Mr. Moon; therefore no further action was taken to process that portion of his FOIPA request. One main file was located concerning the Unification Church; however, the requester was not willing to pay the fees for processing that file and no documents were released to him. Philadelphia file 190-1258 was then closed.






