## Global Peace Festival (GPF) 2011 in Mongolia completely failed Presidential Office and Government

Withdrew Their Involvement with Suspicious Kwak's Group and Hyun-jin nim 9,600 Participated in Main Event (Police Announced)



In response to these, the parliament on July 20 legislated the government decree, "Organizing Global Peace Festival of World Mongolians," by initiative of the minister of foreign affairs and trade, and it approved the budget of 150 million Tugleg (about 120,000 US dollars). However, as a result of the office of Mongolian president and the government's re-verifying to the Kwak's Group, Hyun-jin nim and, the UCI Leadership who promote GPF, upon its enforcement, they decided to minimize their engagement.

In order to express their respect for and moral obligation to foreign visitors, at the night of August 25, the foreign minister hosted dinner, and in the morning of August 26 the parliament dispatched a member as its representative to the wreath-laying ceremony by which to honor the heroes of Mongolia. However, even a Mongolian official did not show up on the stage at the opening plenary of the international conference ("Mongolia and Northeast Asia Peace" is its theme) convened in the government palace on the 26<sup>th</sup>, nor was even such a participant there. (Refer to the picture.)



Furthermore, no member of parliament from Mongolia, the host nation, attended the Parliamentary Roundtable, a subcommittee where parliamentarians from each country were to discuss. This situation was abnormal. (Refer to the picture.)



The international conference finally adopted "Ulaanbaatar Declaration" as its compilation on the 27<sup>th</sup> [the 2<sup>nd</sup> day of the conference]. Yet again any government official did not appear here at all. (Mr. Shagdarsuren, a former member of the parliament made a speech upon the adopting. Refer to the picture.)



Even in the GPF 2008 when any official relation was not made with the office of the president or the government, in its opening plenary of the international conference, the message of the then president, Enkhbayar, was read by a representative of its office, and Enkhbold, the deputy prime minister of the government addressed the audience. (Refer to the picture.)



Compared with this track record, performance of this year's GPF was especially inferior.

The situation was strange itself to foreign guests and domestic participants with good consciousness, since Mongolian officials, owners of the government house, never showed up. Wasn't it natural for participating Ambassadors for Peace to say that "what on earth happened to the President and the Foreign Minister?"

Surprisingly, even a government official did not appear in the main event held from the evening to the night of August 27, but it was its master of ceremony (referred to as the picture) that introduced Hyun-jin nim to the audience upon his speech.



As compared with the occasion of the previous GPF 2008 when a parliament member's congratulatory address was made and the finance minister (referred to as the picture) ardently introduced Hyun-jin nim on the stage, the situation was shocking.



The number of the audience gathered in the Sukhbaatar Square was also markedly small compared with 2008. And the police announced the number as 9,600 persons. Should not the host accept this objective fact?

The speech of Hyun-jin nim was as short as 15 minutes including consecutive translation. In spite of

affirmation of "One Family under God" as its main idea, much audience said that its ideological grounds were weak and its persuasive power was missing. Furthermore, the speech never mentioned True Parents.

Thus, the fact that Hyun-jin nim did not express his respect and love toward True Parents will spread as a shocking wave throughout all people in the world admiring True Parents from their heart.

The current providence which members of Unificationism see has come to gaining the realm of victory in which True Parents became the substance of God. However, Hyun-jin nim does not live a life of attendance at True Parents who completely achieved oneness with God, but regrettably against True Parents' desire, Hyun-jin nim promotes GPF by which to give pain to True Parents' heart. Under such a condition on the one hand, Hyun-jin nim preaches God on the other hand, which includes contradiction.

Thus, since the speech included such spiritual inconsistency, even if ardently explaining God, it was natural that it could not invite divine spirit or could not bring a sense of togetherness as family fellows among the audience.

Some other participants said concerning Hyun-jin nim's posture that he often lowered his head and deeply thought of something during listening to others' speeches and comments in the international conference.

Within Mongolia, still many members of Unificationism are unable to detect the deceptive nature of Hyun-jin nim surrounded by the Kwak's Group and UCI leadership, due to their manipulation of information. Even many of Ambassadors for Peace here, in addition, misunderstand domestic situations of the true family due to wrong information given by such UCI leadership.

However, Ambassadors for Peace conscious of the reality came to harbor a question in GPF Mongolian 2011 not reflecting upon the great advertisement of presidential support or governmental joint sponsorship. The background lies in the office of the president and the Mongolian government having withdrawn the participation to GPF.

How they came to withdraw their involvement?

It is clear, through the True Parents' Proclamation dated on May 25 of this year, that Hyun-jin nim surrounded by Kwak's group and UCI have been currently away from True Parents' will. (Refer to the picture.)



In addition to this official position announced in the name of True Parents, the office of Mongolian president and the government checked the fact through their own verification process, and reconfirmed the fallacy of the Kwak's group, Hyun-jin nim, and UCI.

The membership base of every country throughout the world and the foundation of Ambassadors for Peace including the head of state of many countries come from the results of true love and sincerity of True Parents' whole life to the world. It is natural for the office of the president and the government to decide that they should not cooperate with such Kwak's group, Hyun-jin nim, and UCI that are against True Parents' will, abuse public property, and trample their heart.

Furthermore, the office of the president and the government newly recognized to protect Mongolian citizens possibly deceived by UCI, and decided to respect True Parents' desire.

The Kwak's group, Hyun-jin nim, and UCI executives take a leadership that creates an image as if they inherited True Parents' will and realized it, under which in Mongolia they control information, lead youths and Ambassadors for Peace, and manage various related NGOs. However, the reality is that they disregard True Parents' direction, abuse public fund, and promote the GPF infringing on their heart. The office of the president and the government clearly penetrated such their deceptive leadership.

Then, the office of the president and the government took the measures which minimized their

involvement in GPF Mongolian 2011, in the responsibility to take care of many Mongolian citizens including Ambassadors for Peace who respect True Parents. Thus, the policy of the office of the president and the government made by their historical decision for the sake of Mongolian citizens is worth highly evaluating over future generations.

The president of Mongolia and the government left their work record of implementation of the policy to protect Mongolian citizens by minimizing their engagement, after detecting the deceptive leadership by the Kwak's group, Hyun-jin nim, and UCI executives, though once having announced their active involvement and even approved the budget. It is natural for the office of the president and the government to afterwards refer to the record in the archives.

Despite the set purpose of enterprising the GPF in cooperation with the head of state and the government, the Kwak's group, Hyun-jin nim, and UCI executives who are the co-sponsors obtained a by-product called distrust from them, the very expected partners. It is not guessable how severely this outcome affected them in promoting the future activities of the GPF.

Those who know the essence of this hard hit recognize that it is not an issue any longer to externally argue who participated or how many gathered. Involvement of the office of the president and the government was controlled to a minimum, and the number of the audience gathered in the main event was also incomparable with the case of 2008. More than these facts, however, it is serious that the Kwak's group and Hyun-jin nim were branded distrustful and the UCI executives dangerous by the State of Mongolia. In this regard, GPF Mongolian 2011 ended in merciless failure in its essence.

The Kwak's group and the UCI leaders are making an exaggerated announcement regarding the number of people gathered in the main event by using the number 100,000 or 60,000, which do not have any basis and are against 9,600 released by the police.

However, such numbers are false and different from the fact. Continuing such a false act makes their deceptive nature disclosed, and it only contributes to increasing in the degree of distrust of Mongolian public agencies, and never leads to attaining the original purpose of GPF.

On the other hand, the office of the president and the government, as planned, maintained their policy of full-scale cooperation with the "Congress of World Mongolians," which they had decided to sponsor almost at the same as GPF Mongolia 2011, and were actively involved including participation of the president and the minister of foreign affairs and trade in the plenary session. In conclusion, the Kwak's group, Hyun-jin nim, and UCI executives, due to their deceptive nature, by themselves invited distrust from the office of the president and the government; and by succeedingly their having an attitude deceiving Mongolian people through exaggerated advertisement without repenting the nature, GPF Mongolian 2011 ended in merciless failure; and this was forever recorded in history.

GPF in Mongolian has no hope without their coming back under True Parents, putting their perfect life of attendance into practice, and reconstructing a track record from the beginning, after reflecting upon their deceptive nature and fundamentally changing their attitude.

It is December 2009 that Mr. Chung Hwan Kwak stopped attending Hoondokhwe centered on True Parents. And it is September 2009 that Hyun-jin nim most recently spent time with True Parents in Las Vegas of the U.S. Namely, many months have already passed since the Kwak's group and all the members of Hyun-jin nim family left True Parents' bosom. We expect them to correct their thoughts and return to the bosom of True Parents as early as possible.
