As Hyung Jin Nim was traveling to a Veterans Benefit event in Texas this past weekend, he asked me to give the sermon to brothers and sisters on Sunday. I gave a report on his deposition by Family Federation lawyers last week in their trademark lawsuit against him and the Unification Sanctuary for daring to use the Tongil symbol that True Father designed and wanted all Unificationists who believed in him and his teachings to use. Family Fed's lawsuit also seeks to stop Sanctuary from using the term, "Cheon Il Guk."



Afterwards I gave a presentation based on Hyung Jin Nim's soon-to-be-published *Our Father Forsaken* book called "The War on Natural Law" which describes how America's roots in the Judeo-Christian worldview are threatened by efforts to impose transgenderism on the American people through the public schools, courts, libraries, medical and mental health institutions.

During his 15 hour deposition by Family Fed lawyers at the Radisson hotel in Scranton on June 18-19, Hyung Jin Nim was interrogated by the lead attorney, Jim Rosenfeld, of the Davis, Wright and Tremain law firm.

On Tuesday (the first day), he was asked about the source of his claim to be the legitimate leader of the Unification Movement and about the meaning of the term "Teshinja." Hyung Jin Nim explained that it means that Father viewed him as "the person who acts on my behalf" or his "representative body." He spoke about how [True Father appointed him as his heir and representative](#) with the full authority of True Parents in April, 2008 and about the [three ceremonies in January 2009](#) where Father crowned him, making him wear Father's own crown and own holy robe to wear, the only one to do so besides True Father himself. He explained that he was the only one who officiated an International Blessing sacrament ceremony in True Father's stead. This was True Father's choice, not his own.

He also spoke about the Hak Ja Han's crime of changing the words of the returning Christ. Even in the secular world the spouse of a respected author or artist knows they cannot revise or change his/her manuscripts or art!

Everything that Hyung Jin Nim says is in the public domain, so his deposition on June 18-19 and those of other Sanctuary representatives should also be made public as soon as possible. Sanctuary Church makes [financial reports public](#) every year here in the U.S. and in Korea. The **Family Federation should also make the Han Mother's deposition public and ALL of True Father's words and video recordings should be made public as well.**

At Wednesday's deposition, the Family Fed lawyers asked about a video of Hyung Jin Nim's Feb. 8, 2015 Declaration of Heaven sermon where he showed the video of True Father writing the Declaration on June 5, 2010 which states that Hyung Jin Moon is the representative and heir. Anybody else would be a heretic and destroyer." Hyung Jin Nim pointed out that there is no signature by Hak Ja Han, just that of Sun Myung Moon. If they were truly "equal," why didn't she sign the declaration?

In 2013 and 2014 he was still trying to help Mother to do the right thing. He kept on trying to meet with her until she stopped meeting with him and had 40 security guards come out to block him from visiting her in the Cheon Jeong Goon palace. That was the last time he tried to meet with her.

In the afternoon session on Wednesday, he was asked if Sanctuary was using the Tongil symbol for promotion and "branding?" **He responded that the Tongil mark is part of our spiritual practice including Blessing Rings, Wonjeon ceremonies, etc. Some even draw the symbol with their hands when bowing. For us, it is not a "brand," it is part of our faith.**

When asked about Sanctuary's use of the words "Cheon Il Guk," Hyung Jin Nim explained that each of the 8 pledges in the Family Pledge which faithful Unificationists speak on all holidays and Ahn Shil pledge days, starts with the phrase "owner of Cheon Il Guk" on. It is key to our faith identity. It refers to a future nation that will exist in reality.

The King's Reflections after the 15 hours Deposition part 1

Folks, thank you so much for your prayers and for your love and conditions- a lot of people did vigils. Thank you so much. It really makes a huge difference!

We did 15 hours of deposition. It was pretty exhausting, pretty, pretty exhausting, but I believe our side stated our point. The lawyer said we did very well.

Tim: He said you were perfect.

The King: Yes he said it was perfect.

But everybody's prayers gave me tremendous power. But these prayers and people were doing conditions around the world, and vigils, so I just want to thank everybody for all your prayers and your concern and standing up for God and standing up for Christ's kingship and standing there together with us in the Gethsemane condition! So it was a very long two days, a very long two days, and very grueling two days!

Because the other side is trying to trip you up and make you do mistakes so you have to stay focused, in prayer; you have to stay centered and you have to stay flexible, yet you have to be firm etc...

In any case at some point all the depositions will be online; they will be released by the judge, so everybody will be able to see them with their own eyes. It was a great historical record; we were able to proclaim True Father and it is going to remain as historical record, and for everybody to see, so in that sense it was a good experience and a good opportunity, but again it was a very long and grueling session. 15 hours!

So I definitely do appreciate your prayers. Maybe we'll do a shorter rhema today. I'm a little exhausted- I have to say!

2nd King of CIG- The King's Report

I could not have done it without your prayers, and your concern and your love!!!! part 2/3

----- Let's go quickly to our Rodofiron Instagram page, and let's see our latest post. (The King shows and comments) ... We are thanking everybody in Korean and thanking everybody for the prayers.... We thank the folks that came out yesterday. They don't understand how much spiritual power they gave me. I mean every break I was able to see them, and every break they were just doing vigil, and every break could be mental and spiritual break, and the folks were right there encouraging me. I could just feel the activation of spirit world all around, all around, and we had spiritual power.

It was exhausting because it is a grueling 15 hours deposition time where they really try to gruel you and they want you to purge yourself; they want you to say something like this or say something like that, and kind of contradict yourself. Then they want to take those clips in front of the judge and say, "Look, look, he is lying, he is lying!" So you have to be very careful with what you say.

So it's a lot of mental trophotropic training. But I remember the queen said for example, when she finished her deposition; it was one day, but she said she was knocked out after she got home. She literally collapsed because it was so much stress. You know you have to be very cautious of your answers etc...

So in that regard, it was like trophotropic training and I felt eventually that their side was getting tired towards the end.

But we thank everybody that came out, and was praying for us, and all the spirit world and the heavenly host of angels and True Father in heaven, and True Mother in heaven, all of the folks and all of the spirit world I felt were mobilized, were standing, and we had the opportunity to proclaim and declare. It was powerful!

Firstly I think I must have called them heretics and bureaucrats and illegitimate usurpers and totalitarians about a million times (laughing). So they were pretty beat up by the end of the day, it seemed like. But I was just stating the truth and also the fact that I am Father's hand-picked, hand-vetted heir and successor, representative body, inheritor of the Lord of Lords and the King of Kings, and returning Jesus. So I kept on telling them that because it's the truth.

And it was interesting because every time I said that, the demons would be squirming; you would see their faces just crinkle up into prunes. Every time I called them, 'illegitimate bureaucrats' or 'wannabe totalitarians' or 'little fake dictators' or whatever the case may be, they would just squirm, squirm. And every time I was saying, "Father never put his crown on

these bureaucrats," - I would say that a lot- they would squirm, squirm, squirm. But I mean that's what they deserve.

They are the ones who are suing me; for what? Using my father's symbol! I mean it's the most stupid thing I've ever heard in my life, seriously! They are so pathetic! They are so defeated! They are so incompetent and petty! First of all they stole all my assets that my father bequeathed to me. They have hundreds of millions of dollars and then they want to sue Sanctuary Church which is this tiny little church in the countryside for using the symbol. It's the stupidest, most totalitarian. But you can see it's because the truth is so ravaging to their lies and their corruption!

They even gave me some kind of document and they are saying, "Can you comment on this?" There are five pages, and four of them it's all black pages. All back pages! They are saying, "The rest of the pages are redacted." No! They are not redacted! They are black pages! Everything is black! Even the federal government when they release something and they say, "It's redacted," you can see some lettering, right? There was absolutely no lettering! They hid everything regarding the content of that meeting! And I was saying, "Why don't you show me the meeting?"

So I showed the black pages, "Look how ridiculous this is! Look at this!" I'm showing to the camera, because it's the stupidest, most ridiculous thing I have ever seen. You are going to ask me about the meeting, and then you're going to black out everything in the freaking notes. It's so ridiculous!

They obviously have things to hide, right? Because I think at that meeting Kook Jin Hyung said, "You traitors, you are traitors!" or something like that. They are just such pathetic and petty, and sad, demonic worms; they are just little insects. They are so pathetic, and they are so illegitimate, them trying to just hold on to what Father clearly gave authority to his son, his heir and successor, to oversee all these things.

So it was a long two days! They had me two days, so for 15 hours. That's not 15 hours of total time, that's 15 hours of camera time, or deposition time. You add in all the breaks and all the other discussions and group meetings ... so it's like probably 20 hours or something like that. So it's been a very long two days, folks!

But seriously if I did not have all of your prayers- oh my gosh! I would feel so empty and vapid; I would feel so dried up like a desert! But through everybody and through their prayers ... I know in Korea, they did overnight vigils and Japan as well, and Europe, and I heard also the Philippines. Thank you so much everybody! I truly, truly appreciate!

It allowed the rivers of living waters to continue to flow. It allowed me to remain in the subject position. It allowed me to stand strong and to declare the truth, and to rebuke the devil. I could

not have done it without your prayers, and your concern and your love. I could not have done it without you all. I just felt everybody was standing with me there, standing with me in front of all those lawyers and the demons, the traitors to Father. It allowed me to just remain in my position, remain strong; remain true, consistent and true, truthful, you know true and truthful.

So it was a very powerful two days but again very, very, exhausting. So I do thank again one more time everybody who came out. It really did make a huge difference.

To Tim: how did you feel about the deposition? Can you talk about how you felt?

Tim: actually at the end the lawyers agreed that you could talk freely about that.

The King: you can talk freely about the deposition? So they will be put out on the Internet?

Tim: You can talk about it. Some of the exhibit, especially the black one that you mentioned just now...

The King: have you ever seen anything like that?

Tim: No I don't think; I have not.

The King: what else? What were your reflections on these two days?

Tim: Well I've been to quite a few of these depositions now. In the beginning each side chose seven people from the other side that they wanted to depose, and each added maybe one or two. Our depositions have been completed, people being deposed from our side. We have just one more left that we are going to be deposing: Mike Balcomb later this month. I think that will be the last one.

But they are all pretty grueling. I was in the seat once for a day; one day. This is a federal case, and according to the rules in federal court the normal thing is to do seven hours of camera time on record time, seven hours.

The King: they had me for 15; they had me for double time!

Tim: The thing is we had Hak Ja Han for ten hours over two days, so the judge also gave them ten hours with you. But there were the additional five hours where you were speaking as the representative of the corporation. So that's separate from the individual. That's why yours was extended to 15.

You know our lawyers argued, "Listen the reason we needed ten hours for Hak Ja Han is because she was speaking through an interpreter." As a matter of fact she was speaking through two interpreters.

The King: so everything is double slow

Tim: double slow and more than double slow I would say. But the judge still said, "Well I gave you ten hours with her, so they get ten hours with him." So that's how he finally reasoned it. In the end what the judge says goes; we can't change it unless we want to appeal it to a higher appeals court, but there is no sense in doing that probably. Your deposition was the longest of any.

The King: yes it was very long! Man it was long! It's hard to stay on point for ten freaking hours!

Tim: yes it is; it is.

The King: but it's everybody's prayer. I think it is the prayer power that allowed me to just stay, just hammering, hammering, just endless battering and hammering. That's what I felt. I felt it's the spiritual power of every body's prayers and people doing conditions and vigils, and staying up overnight and praying, it's all that spiritual power. I just felt it was a supernatural power.

I could feel Father's prayers. Every time we were declaring him, I could feel True Father and True Mother in heaven, and they are smiling and they are saying, "Get them boy! Go get them my son! Tell them the truth! Tell these traitors the truth! Tell them of their damnation, and that they are going to hell!" and this kind of stuff. It was very powerful! I mean it was very long and arduous but a very powerful, powerful experience.

To Tim: Any other reflections you had on that?

Tim: From my own experience as well: the lawyer gives you certain guidelines and rules before you begin, but it's very difficult to maintain that over a period of hours and hours and hours, especially if I had to do 15 hours, I don't think I could have done nearly as well as you did. I know I did not even do it in a single day, so it was really incredible what you did.

The King: Well I just feel we had a great counsel, and everybody's support, everybody's prayers, and of course we had our brothers and sisters sitting in the room as well, which was a great comfort. They could see with their own eyes the depositions, which I think was good. It was great. And the young people also could see what these depositions are about. It's also good for them to see because in the future they may be sued for something, I don't know. They may have to fight.

Hyung Jin Nim's Deposition by FFWPU Lawyers on June 18-19, 2019

Background: Last July, 2018 the Family Federation for World Peace and Unification (legally known as the Holy Spirit Association for the Unification of World Christianity) filed a trademark lawsuit against Hyung Jin Moon and the Unification Sanctuary in the U.S. Middle District Court in Harrisburg, charging him and Sanctuary with improperly using the 12 gate Tongil symbol and the term "Cheon Il Guk" which HSAUWC claims as their "property."

During his 15 hour deposition by Family Fed lawyers at the Radisson hotel in Scranton on June 18-19, Hyung Jin Nim was interrogated by the lead attorney, Jim Rosenfeld, of the Davis Wright and Tremain law firm.

On Tuesday, he was asked about the source of his claim to be the legitimate leader of the Unification Movement and about the meaning of the term "Teshinja." Hyung Jin Nim explained that It means that Father viewed him as "the person who acts on my behalf" or his "representative body." He spoke about how True Father appointed him as heir and representative with the full authority of True Parents in April, 2008. (see video at <https://vimeo.com/136459083>)

He spoke about the three ceremonies where Father crowned him in January 2009, making him wear Father's own crown and own holy robe to wear, the only one to do so besides True Father himself. <https://vimeo.com/142034097> He explained that he was the only one who officiated an International Blessing sacrament ceremony in True Father's stead.

He also spoke about the Hak Ja Han's crime of changing the words of the returning Christ. Even in the secular world the spouse of a respected author or artist knows they cannot revise or change his/her manuscripts or art!

When asked if he believes in True Father's words, Hyung Jin Nim explained that Father appointed an heir and blood line that will always exist on earth, giving authoritative guidance about True Father's teachings and rejecting heresies like that of Hak Ja Han, which deviate from the core teachings of the Divine Principle.

He said, "we believe in the faith, love and lineage of Christ, who established a Kingship line that will preserve his authority and culture. None of the critics have been crowned and anointed. I did not choose myself."

He explained that after True Father's passing, Hyung Jin Nim begged his mother not to change Father's words, which she and the Family Fed are changing for their personal agendas and benefit. They will be punished for their crimes. Hak Ja Han officiates Blessings by herself, which is totally outside of Father's traditions.

The anointed heir has authority in terms of traditions, theology, etc. True Father said that Hyung Jin Nim had the highest level of faith in the entire Unification Movement and that he is fully capable to represent True Father in a way that gives Father joy.

When asked if he was "perfect," (as described in DP discussion of three stages of growth), Hyung Jin Nim said a better translation is "complete" and explained that the completion level means that you will not betray God. It's more an issue of love. He could have declined to undergo True Father's training, but instead did so and fulfilled his 5%.

The term “Champungonim” in Korean can be plural or singular. Everyone knew that True Father was the owner and subject of True Parents. He had 95% responsibility and Hak Ja Han had 5% responsibility (representing humanity) to be obedient.

True Father taught that Cheon Il Guk represents the nation of the Kingdom of God and prophesied that his heir would release the constitution. On August 30, 2015 Hyung Jin Nim issued the Cosmic Declaration of Cheon Il Guk which speaks about the protection of lineage, of human rights, and about avoiding corruption as well as the Bill of Human Rights of Cheon Il Guk. True Father loved the U.S., which freed him from the Heungnam death camp. The U.S. Constitution is the highest document of a free nation so far, at the growth stage. It is very close to the Kingdom of God, giving the most freedom to people and putting chains on the government. But it can be taken over by socialism. That is why the CIG constitution has no amendment process.

Everything that Hyung Jin Nim says is in the public domain, so his deposition on June 18-19 and those of other Sanctuary representatives should also be made public as soon as possible. The Family Federation should make the Han Mother’s deposition and ALL of True Father’s words and video recordings should be made public as well.

Mr. Rosenfeld asked about meaning of lineage. Hyung Jin Nim explained that True Father taught that the central truth of the universe is the father/son relationship, saying that, “Father vetted me for 2 – 2.5 years. From the Biblical context, the blessing and birthright is always passed from father to son. The father has the seed. The Korean word Sansookja means inheritor. Choon su means “I pass down.” Like Jacob passing the blessing to Isaac who passed it on to Jacob. It was 100% Father’s decision. This is not only a legacy of ‘teachings,’ but a substantial lineage.”

When asked about the Feb. 13, 2013 “Foundation Day” event, which Hyung Jin Nim described as the false Foundation Day, he explained that True Father canceled the Perfection Level Blessing of True Parents the year before. “Hak Ja Han tried to force me to pray to ‘Heavenly Parents,’” which he did not do. He was cooperating and acting out of the hope that his mother would not pursue an evil direction.

Hyung Jin Nim was also asked about the Nov. 14, 2009 sermon he gave where he said that brothers and sisters should only follow and glorify True Parents, not the True Children and that “If any one denies True Parents, do not follow them.” Hyung Jin Nim explained that True Father, the Christ, is the absolute center of True Parents. Hak Ja Han was a sinner saved by grace. When she rebelled against True Father, by changing the 8 Great Textbooks, the Family Pledge, the name of God, lifting up herself instead of True Father, etc. she was no longer part of “True Parents.”

God requires us to discern between good and evil, between consistency with True Father or disobedience with him.

At Wednesday’s deposition, the Family Fed lawyers asked about a video of Hyung Jin Nim’s Feb. 8, 2015 Declaration of Heaven sermon where he showed the video of True Father writing the Declaration on June 5, 2010 which states that Hyung Jin Moon is the representative and heir. Anybody else would be a heretic and destroyer.” Hyung Jin

Nim pointed out that there is no signature by Hak Ja Han, just that of Sun Myung Moon. If they were truly “equal,” why didn’t she sign the declaration?

He spoke about how the church bureaucracy was angry about his efforts to decentralize the church and to give church families more autonomy, which reduced their control over the people. So they aligned with the Han heresy and took action to have Hyung Jin Nim removed from all of his church leadership positions in Korea. In so doing they were aiding and abetting a desecration of True Father.

Some, like Tim Elder and Rev. Seong Hyul Lee, left to serve True Father’s anointed heir.

Mr. Rosenfeld asked, “In Feb. 2015, did you direct your members to elect local representatives?” Hyung Jin Nim said that brothers & sisters were free to choose their own leaders. He urged leaders to be transparent in their finances.

The FFWPU should do this and make videos public. Sanctuary Church makes financial reports public every year here in the U.S. (<https://www.sanctuary-pa.org/financials>) and in Korea.

Mr. Rosenfeld showed a video of a district meeting at East Garden in November 2012 where HJN said “I must attend to Mother as my messiah, as the loving God.” Hyung Jin Nim responded that if she attended True Father through her 5% responsibility, that statement would still be true. She would be overflowing with the Holy Spirit. Instead she points only to herself and colluded with self-serving leaders.

He was still trying to negotiate his relationship with Mother and speaking to her in respectful language. He kept on trying to meet with her in 2013 and 2014 until she stopped meeting with him and had 40 security guards block him from visiting her in the Cheon Jeong Goon palace. That was the last time he tried to meet with her.

In the afternoon session on Wednesday, he was asked if Sanctuary was using the Tongil symbol for promotion and “branding?” He responded that the Tongil mark is part of our spiritual practice including Blessing Rings, Wonjeon ceremonies, etc. Some even draw the symbol with their hands when bowing. 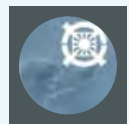

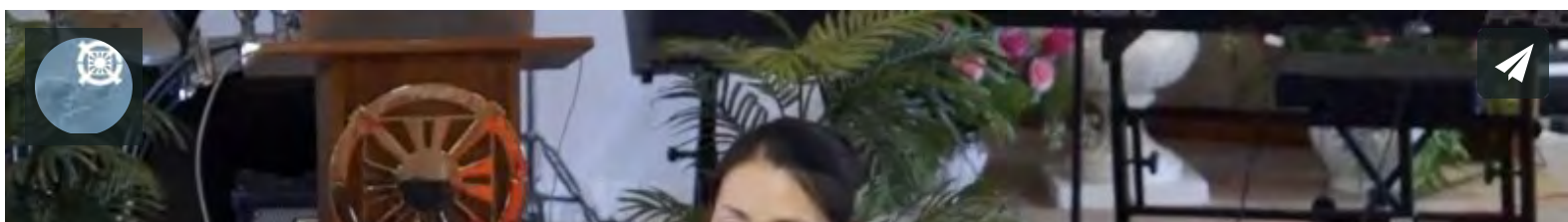

The Great Coronation of the Authority of Liberation of God, the King of Kings

March 15, 2015



The historical January 2009 coronation ceremony that was held three times—"The Great Coronation of the Authority of Liberation of God, the King of Kings"—as explained by Rev. Hyung Jin Moon (on March 15, 2015—video below).

The Rev. Sun Myung Moon held this same ceremony on three different occasions and two continents. The ceremony was held on January 15, 2009 in Korea and also again on January 31, 2009 in Korea and then in New York, NY (possible due to the time difference between the countries) in the United States. The Rev. Sun Myung Moon stated the following in the three ceremonies, using Korean language and verb usage used in Korean for addressing God:

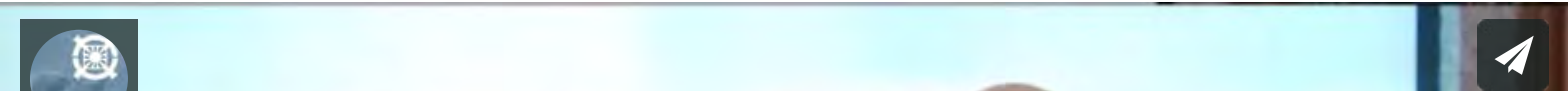
