Shin Albania Activities

They will be joined later by a group of eight young people from Russia.




Belarus Celebrates 28th Anniversary of True Mother's Visit






Moldova Activities






Russia CARP Activities


"World of the Family" Celebrates Families in Diverse Cultures

Multiple violations in enforced expulsions from Russia of two foreign missionaries

In today's Chamber judgment¹ in the case of Corley and Others v. Russia (application nos. 292/06 and 43490/06) the European Court of Human Rights held, unanimously, that there had been:

a violation of Article 1 of Protocol No. 7 (procedural safeguards relating to expulsion of aliens) to the European Convention on Human Rights in respect of the two missionary applicants (Mr Corley and Mr Igarashi);

a violation of Article 2 of Protocol No. 4 (freedom of movement) to the European Convention in respect of Mr Igarashi;

a violation of Article 9 (freedom of thought, conscience and religion) of the Convention in respect of Mr Corley and Mr Igarashi;

a violation of Article 8 (right to respect for private and family life) in respect of Mr Corley and Mr Igarashi and their families;

a violation of Article 3 (prohibition of inhuman or degrading treatment) on account of Mr Igarashi's degrading conditions of detention; and

a violation of Article 5 §§ 1 and 5 (right to liberty and security) in respect of Mr Igarashi.

The case concerned the sudden and enforced expulsion from Russia of two missionaries of the Unification Church, ostensibly for violating residence regulations.

The Court found in particular that the authorities had deliberately expedited the proceedings, dispensing with the legal formalities and thus denying Mr Corley and Mr Igarashi the possibility of exercising their procedural rights prior to their expulsion. On 23 November, the European Court of Human Rights (ECHR) made a ruling in favour of Unification Church missionaries Jack Corley and Shuji Igarashi. In January 2006, Jack Corley was illegally deported from the Russian Federation. Several months later, Shuji Igarashi was likewise deported. Both were banned from returning to Russia for a minimum of five years. The ECHR ruling means that it recognises the religious freedom rights of members of the Unification Church and is willing to defend those rights.
