To your point #1

“After receiving the Messiah and being restored to the position of the first human ancestors before their Fall, a path still remains to be trod: we must become one with the Messiah centered on the Heart of God, then follow him along the uncharted path to the summit of the growing period, and thus finally become perfect incarnations.” (DP, Part II, Section 1.2.2, 1st Paragraph)

In other words, thinking inside the box can get us to the top of the growth stage, but not beyond. Marketers know that thinking outside the box is uncomfortable for 85% of the people, they resist it. If we fail to think outside the box we will fail to grasp God’s Completion stage providence.

To your point #2

When I was fundraising, If I abandoned my internal goal just to make a sale in the hopes of achieving my external goal, then I would be punished later for it. Period.

To your point #3

Adam and Eve lost their blood lineage through sex. This is why we regained God’s lineage through the 3 day ceremony. The ceremony was just as physical as the physical fall. Logically speaking, if the physical fall was sufficient enough to change the blood lineage of A and E from God’s to Satan's, then the 3 day ceremony is just as valid. The DP says that spirit cannot grow or change apart from Physical action, thus without the 3 day ceremony being commissioned by the True Parents, then the physical path to “change of lineage” is closed.
