May the Heavenly Parent and True Parents' blessings and love be with you all.

This is to inform you that the 2023 CheonBo Evaluation will be conducted as outlined below. We ask your cooperation in proceeding in accordance with the following guidelines in order to help as many couples as possible to participate.

I. Overview of the Evaluation Process

- A. Target Participants: CheonBo candidates that can submit all supporting documents for evaluation in the five main areas of evaluation by September 30, 2023.
- B. Method of Evaluation
 - 1) The process will be conducted through the CheonBo evaluation website.
 - 2) Procedure
 - A) The CheonBo candidate creates a website (<https://cheonbov.org>) account.
 - B) The CheonBo candidate uploads supporting documents for evaluation and registers for evaluation.
 - C) The CheonBo candidate's church leader recommends the CheonBo candidate.
 - D) The CheonBo candidate passes through the three levels of screening for the five main areas of evaluation.
 - 3) Evaluation Schedule

- A. The passing score in the evaluation is a total of at least 85 points.
- B. Evaluation Criteria
 - 1) Ancestor Blessing: Submit the certificate of completion of the Blessing of 430 generations of Ancestors in eight lines, issued by the HJ Heaven and Earth CheonBo Training Center.
 - 2) Tribal Blessing: Submit the certificate of completion issued by the regional headquarters.

- 2) How Blessing counts the results of completion based on the regional headquarters
- A) Complete the Blessing of at least 430 married couples and/or unmarried Blessing candidates from the three generations of one's spiritual tribe.
 - B) If someone brings 43 unmarried Blessing candidate couples to receive the Blessing, he or she will be considered to have completed the horizontal aspect of Heavenly Tribal Messiahship.
 - C) Regulations on the recognition of Blessing activities in countries where the candidate is not resident:
 - ① The results of Blessing activities conducted in other countries before the announcement of the official international regulations on Heavenly Tribal Messiah mission (June 29, 2018), indicated in the FFWPU Official Memo 2018-144, are recognized.
 - ② The recognition of Blessing activities conducted in other countries within the period after the announcement of official international regulations on Heavenly Tribal Messiah mission (June 29, 2018) indicated in the FFWPU Official Memo 2018-144, and October 31, 2019, is decided according to the regulations of the relevant regional headquarters.
 - ③ Blessing activities conducted in other countries on or after November 1, 2019, are not recognized for the purpose of this evaluation.
 - ④ Blessing activities conducted by national messiahs in their mission country, and overseas Blessing activities conducted by missionaries (and others with public missions) authorized by IHQ while carrying out their mission in their mission country are all recognized regardless of the time restrictions stated above.
 - ⑤ For cases where the overseas HTM results is within the scope of recognition, the candidate must receive the 'Certificate of Confirmation of Overseas HTM Blessing Activity' from the regional headquarters of the relevant mission country and submit the document to the current regional headquarters you are now affiliated with. This document may be issued using the format provided during previous CheonBo evaluations.
 - ⑥ The Blessing donation of gratitude shall be made in accordance with the donation standard of the country of affiliation of the Cheonbo candidate. Donations may be made through the national headquarters or regional headquarters of his or her country of affiliation.
 - D) Acknowledgement of the Blessing results (number of people witnessed and blessed) achieved by a spiritual child in another region: Detailed guidelines will be announced later.
- 3) Donation of Gratitude for the Tribal Blessing
- A) Provide a Certificate of Confirmation issued by the regional headquarters you are affiliated with to confirm that you have made all donations of gratitude through your regional headquarters or national headquarters; or
 - B) A written commitment to pay/offer Blessing donations in the future or any other similar agreement/contract will not be accepted as documentary evidence.
- 4) Candidate's life of faith: In accordance with the regional standards and guidelines regarding members' lives of faith, the candidate's church leader will assess the candidate's Sunday service attendance and church donation history based on a point system.
- 5) Special Awards: To earn additional points, candidate couples are required to submit evidence of any awards/citations they have received from their country's national president or from the True Parents up to the date of their Cheonbo application, according to the regulations of their respective region.
