The court accepted the request for a stay of execution of the detention order from Unification Church President Hak Ja Han on the 11th. President Han is scheduled to receive medical treatment at a hospital after her temporary release.

According to legal sources, the 27th Criminal Division of the Seoul Central District Court (Presiding Judge Woo In-seong) granted the request for a stay of execution of the detention order. The stay of execution will be from 10:00 AM on the 12th to 2:00 PM on the 21st. Accordingly, President Han, currently imprisoned at the Seoul Detention Center, is scheduled to be temporarily released on the morning of the 12th under the direction of a special prosecutor. The court previously accepted President Han's request for a stay of execution of the detention order in November of last year. At that time, President Han was released for four days and received medical treatment at a hospital. While still released, President Han's request for an extension of the stay of execution was denied, and she returned to the detention center.

The court restricted President Han's residence during this period to the hospital for treatment. Furthermore, contact is limited to hospital medical staff, attorneys, and those assisting with transportation and meals, while contact with witnesses related to President Han's trial is restricted. The court added a condition that the stay of detention can be revoked if this is violated.

President Han's side previously applied for a stay of detention on the 4th. President Han's side argued for temporary release, stating, "The defendant is elderly and has multiple underlying conditions, requiring hospitalization for several days." President Han is expected to be admitted to a university hospital and receive treatment, including cardiology.




