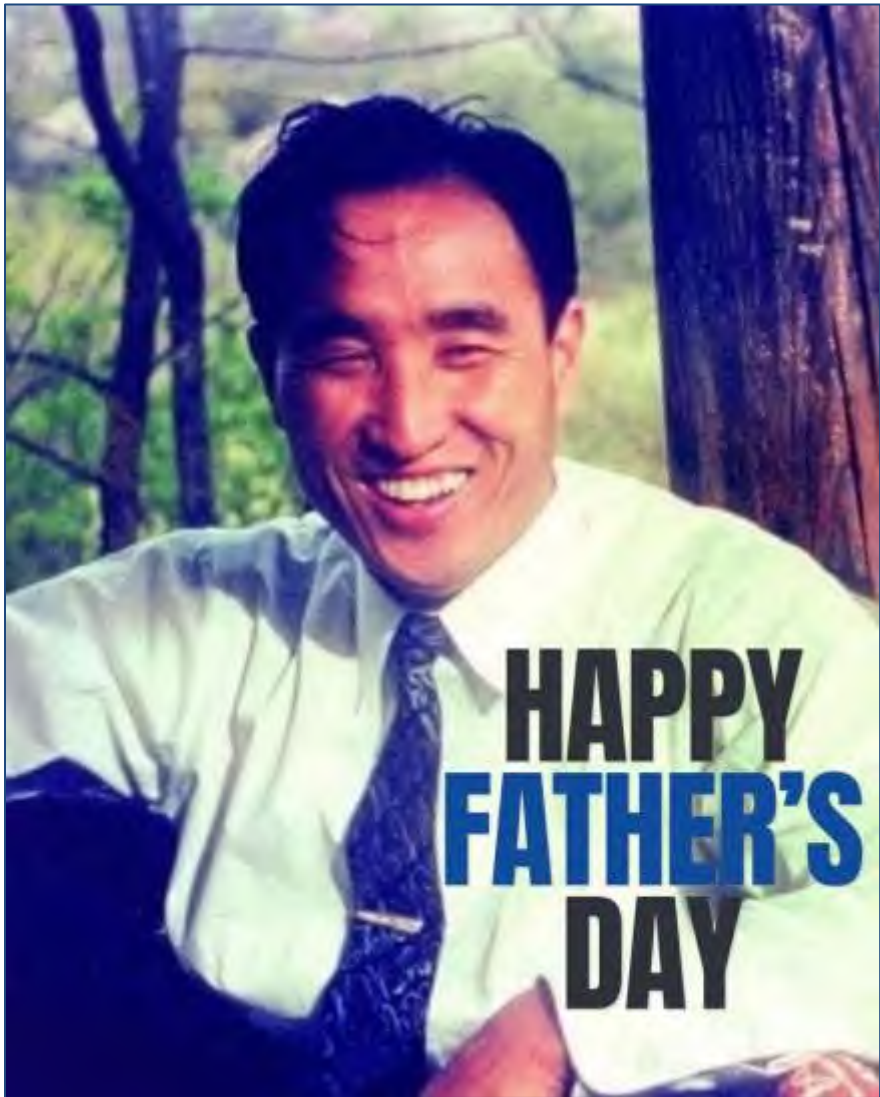

The trial of Family Federation (Unification Church) Dr. Hak Ja Han will conclude on July 10.

The Seoul Central District Court held a continued hearing on June 19, questioning Dr. Han and former world headquarters director Yoon Young-ho.

Dr. Han had stated her position at a previous hearing before refusing to testify, and on this day she again declined to answer most of the special prosecutor's questions or said she could not recall.

When her defense counsel asked how she viewed the claim that Yoon, whom she had trusted, had handled matters on his own and was now shifting responsibility to her, she said she felt betrayed.

She said she learned only later that Yoon had met with Yoon Suk-yeol when he was president-elect, and she denied involvement in the donations to the People Power Party, saying she had received no report on them.

Yoon Young-ho, for his part, argued that he had not been granted comprehensive authority.

He explained that Dr. Han decided personnel and finance matters, and that special events were also decided at the top.

He did acknowledge, however, that in broad terms he, Dr. Han, and former chief of staff Jeong Won-ju had conspired to provide organized support to former President Yoon.

In reporting around December 18, 2025, a person affiliated with the Family Federation described the matter as a deviation carried out by Yoon Young-ho and his associates against Dr. Han's intentions, saying there was never any prior reporting and that only after-the-fact reports were made each time.

The court plans to conclude arguments on July 10 after hearing the special prosecutor's sentencing recommendation and the final statements of Dr. Han and the others.
