A Letter to Beloved Members Around the World from Worldwide Leaders

Beloved members around the world,

Today, the final hearing in True Mother's trial concluded at the Seoul Central District Court. We are deeply aware that members across the globe - despite differences in language and time zones - have accompanied this moment with heartfelt prayer and devotion. With this in mind, we wish to share what took place today.

The Special Prosecutor presented its final opinion, requesting a five-year sentence for the alleged violation of the Political Funds Act and an eight-year sentence for the remaining charges, amounting to a combined request for thirteen years' imprisonment for True Mother. There were also requests for stiff sentences for the other three defendants.

It must be remembered that this recommendation represents the prosecution's position; it is neither the court's ruling nor is the court obliged to accept it. In their closing argument, True Mother's defense team once again underscored that there is no evidence she directly instructed, authorized, or knowingly engaged in any wrongdoing, and they challenged the credibility of the prosecution's key evidence.

The court will issue its verdict on August 31. After that, there may follow an appeal process.

Beloved members,

No one has been more deeply affected by today's sentencing recommendation than True Mother herself. In her statement to the court, True Mother said this -

"I have dedicated my entire life to realizing world peace for humanity. I do not seek power through wealth. As the leader of the Family Federation, I deeply apologize for unintentionally causing public concern in many aspects.

Throughout my life, through the True Family Movement, I have traveled the world emphasizing that we must attend Heaven to realize a peaceful world.

Even now, while bloody conflicts and wars rage across the globe, I still cry out for us to attend Heaven. I have appealed to all nations to attend Heaven as sibling nations, to welcome our Heavenly Parent on Earth, and to fulfill the Heavenly Parent's dream - the Kingdom of Heaven on Earth."

At this moment, the only ones who can truly comfort and strengthen True Mother are we, her children who know her heart. We alone must stand as her unwavering support. We cannot afford to dwell on grief, indignation, or sorrow; instead, we must transform these emotions into the strength that deepens our unity and fosters peace.

We earnestly ask all members across the world to join with one heart and one purpose, offering even greater devotion and prayer for True Mother's vindication and release.

May the abundant grace of Heavenly Parent be with you all. Thank you.
