

Peace Road 2015 World Tour

Waiver and Release of Liability Agreement

Assumption of Risk

- 1. I understand and accept that riding a bicycle, driving motorcycle or a car, or otherwise participating in the Peace Road 2015 World Tour (the "Tour") exposes me to many hazards and entails unavoidable risk of death, personal injury and loss of or damage to property. I also understand that I should be in good physical health to participate in the Tour. I choose to participate in the Tour in spite of these risks and hereby assume all risk of injury or loss of life to myself and loss of or damage to property arising out of riding a bicycle, driving a motorcycle or otherwise participating in the Tour. I understand the inherent risk involved in using bicycle, motorcycle or a car; accept full responsibility for any and all such damage or injury which may result.
- 2. I realize the importance of wearing a helmet and I hereby commit to wearing a helmet at all times while riding the bicycle or driving a motorcycle.

Waiver and Release

- 1. I specifically release and forever discharge HSA-UWC and its officers, agents, and employees from any and all liability or claims for injury, illness, death or loss of or damage to property, which I may suffer while riding a bicycle, driving a motorcycle or otherwise participating in the Tour. This discharge specifically includes, but is not limited to, liability or claims for injury, illness, death or damage caused by the negligence of HSA-UWC or its officers, agents, or employees. It is my intent by the Waiver and Release Agreement to release HSA-UWC and hold it harmless from all liability for any such property loss or damage, personal injury or loss of life, whether caused by the negligence of HSA-UWC or whether based upon breach of contract, breach of warranty, or any other legal theory.
- 2. In signing this document, I fully recognize that if injury, illness, death or damage occurs to me while I am engaged in riding a bicycle, driving a car or otherwise participating in the Tour I forever release and will have no right to make a claim or file a lawsuit against HSA-UWC or its officers, agents or employees, even if they or any of them negligently cause my injury, illness, death or damage.
- 3. I agree to grant HSA-UWC worldwide royalty free license to use my photographic, video, or digital likeness solely for promotional and/or commercial purposes.
- 4. Parent or adult guardian MUST accompany minor for the full duration the Tour.

I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS AN ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY AND I SIGN IT VOLUNTARILY:
