We sincerely thank you for supporting the Hyojeong CheonBo Events and we pray that Heavenly Parent's and True Parents' love will always be with you.

On **October 15th-16th**, the CheonBo EUME Branch will organize a 2 day event in Portugal. Members from all the Heavenly Europe and the Middle-East region are invited to join.

- a) The event will be held in Portugal's Peace Embassy. Members registering a Liberation or Blessing form need to attend the event either in the venue or through live stream in a church center.

Even if members are not doing Ancestor or Collateral Liberation and Blessing, they are still invited to participate either in Portugal or through live stream in a church center.

Even if the members are only participating through live stream, they will also need to pay a registration fee. This will be used to support the hosting nation for the event expenses.

- b) In the 2 day event program, the main ceremonies will take place on October 16th. CheonBo education and speeches from leaders will be given on October 15th. The live stream will be available on both days.
- c) Portuguese members should attend in the Portugal Peace Embassy.
- d) For members living outside of Portugal, we recommend they gather in their church center to follow the live stream. If members cannot go to a church center because of travel distance, they may ask permission from their National Leader to attend from their home.

3. Conditions for Ancestor Liberation and Blessing:

1) Liberation

- a. 21 day condition (50 bows or breakfast fasting).
You can apply even if the condition period starts less than 21 days before the event.
- b. Full payment of liberation donation (donation differs by country)
- c. Members with liberation back payments must complete back payments before doing new liberations. Ancestor Liberation and Blessing must be done in order, starting from 1~7 generations.

2) Blessing

- a. The ancestors can only be blessed if they have completed the 100 day workshop in the spirit world. (100 days after the liberation was done and liberation donation was completed)
- b. Full payment of the Blessing donation
