We received word from the Blessing Ministry Dept. that True Mother wants to be sure as many members as possible can receive this Special Grace.

All requirements, the donation, and the process remain the same

The only change is that, after the Holy Wine Ceremony, the Special Grace Ceremony will now be concluded by watching the recording of True Parents' Blessing Prayer from the 2025 Hyojeong Cosmic Blessing Ceremony.

Below are the details about the Special Grace.

Here are the 6 conditions that we responsible for: 1) 7-day devotion, 2) evening prayer vigil, 3) study of discourse on True Mother revelations, 4) statement of resolve, 5) donation, 6) registration.

1. At least one week of intentional devotion as determined by each family, which can include Hoon Dok Hae, reflection, prayer, bowing etc.

2. At least one, 3-hour Night Prayer Vigil during your one-week devotion period

3. Watch Rev. Dunkley's Discourse on True Mother's Revelations during the one-week devotion period. There are 10 lessons in all and I encourage you to watch them all but at a minimum watch the last one, #10, where he reviews all the lessons. They are all very interesting and inspiring. 4. Completion of a Statement of Resolve to Start Anew. You will offer your document during the Holy Wine Ceremony. I have attached a copy of the form (Statement of Resolve to Start Anew.pdf) but if you cannot print it out, you can just write the responses to the three items on a piece of paper. The three sections are:

1. Repenting for one's past
2. Granting forgiveness to others and releasing grudges and resentments
3. Resolution for a new beginning

Do not put your name on it (God knows who you are). Put it in a sealed envelop and bring it to the Holy Wine Ceremony.

5. Financial donation of gratitude based on the number 13 (\$13, \$130, 1,300 etc). You can make the donation online or at the time of the Holy Wine Ceremony.

This form is for use in registering to receive Special Grace gifted by True Parents to all Blessed Families and Family Federation members for cleansing ourselves in front of Heavenly Parent and True Parents as we prepare for the Entrance Ceremony to the Cheon Won Gung Cheon Il Sanctum.

Preparation

A Special Grace Holy Wine Ceremony will be conducted in local USA churches which requires completion of the following devotional conditions **before attending** by each participant:

1. At least one week of intentional devotion as determined by each family, including Hoondokhae, reflection, prayer, bowing.
2. Participation at least one time in a Cheon Shim Won Night Prayer Vigil (in person or online) during the one-week devotion period.
3. Study of Rev. Dunkley's **Discourse on True Mother's Revelations** series during the one-week devotion period and beyond (access the course [here](#)).
4. Completion of a **Statement of Resolve to Start Anew** document to be presented during the Holy Wine Ceremony (download [here](#)).
5. Completion of a financial donation of gratitude based on the number 13 from each participating family or member. Use this form to make the donation.

Note. Attire for the Holy Wine Ceremony is dark suit for men and light dress for women.

The Special Grace will be bestowed through True Mother's prayer during the Cosmic Blessing Ceremony on April 12, 2025. Those receiving the Cosmic Blessing are to **register here** for the Holy Wine Ceremony but attend it on the day before or day of the Ceremony in its location.
