

## Seattle HPHC: Our 40 days prayer condition for the Windermere Property

Today, February 11, is the 9th day of our 40 days prayer condition Re: Windermere Property. I would like to encourage everyone to really take this condition seriously. Here again are our prayer points:

1. That we can find the right buyer, the would be new owner of Windermere property - the one that can provide us with the best highest offer and can close at the shortest possible time.  
(Clarification: Praying to close at the shortest possible time does not mean that we are rushing to sell the property. We already know that whatever route we take, whether it is sold as a property as is or as a demolished property for development, selling Windermere will have us go through some lengthy process that will require time. And that time can vary depending on the buyer. Thus, time element should be added as a criteria for a good offer from the right buyer.)
2. That we as individuals, families and as a community can be empowered to work to overcome any temptation of Satan to separate and divide us. That we will keep our faith in God, in our True Parents and in Jesus and seek their help so that we can keep our proper relationship with one another as members of our Seattle Heavenly Parent's Holy Community.

At the moment we are hoping that the verbal offer made by someone from the east coast can be put in writing and be submitted to our agent by the end of next week. His offer can be solidify as he close another real estate deal on Wednesday, February 15, 2023. Pray that this person can really be our buyer, the would be new owner of Windermere. That he can really have the money he needed to buy Windermere Mansion. He told us that he plans to buy the building, offer it back to the church as a donation, then "ground lease" it from the church so he can pay for the building maintenance and upgrade. He may rent it to us again or to someone else. He will pay for the property the same price as Hamster Trust offered \$5,750,000.00

Since we don't really know what can happen, our Seattle Property Steering Committee decided that we are not yet letting go of the Hamster Trust offer just in case things don't go well with this person from the east coast. A counter offer is expected to be submitted through our agent by Tuesday, February 13, 2023.
