An Update from Rev. Dunkley: Sept. 18

Beloved Family Members,

The purpose of this film is just to give you a more objective update. True Mother spent about 8 hours with the special prosecution office. She arrived calm, resolute and kind. Here is an instagram video of her

Church members were advised not to gather so as to not cause a disturbance (I believe it would have been better to gather to show support). Unfortunately, the media were not well behaved while True Mother exited the building. Nonetheless True Mother is fine, thank heavens.

, as you may have heard, the prosecutors have asked the court to issue an arrest warrant, which is a standard form of detainment to stop suspects from tampering with evidence.

The legal process for that in Korea starts with a “pretrial detention hearing,” to make sure no one is detained without a proper review; a process to protect people’s rights.

At this stage, a judge listens to both sides and decides whether it's necessary to hold someone while the investigation continues. It will be very telling to see which way the court decides in Mother's case.

Keep in mind this is not a trial. It's not a statement of guilt. It's just one step in a process that's supposed to balance justice with fairness—and hopefully with basic human dignity.
