Dongmo Shin, persona non grata at any of our church properties in Chile. We have long found him a prima donna of the lowest character. He is manipulative, dishonest, even corrupt, and, we believe, despised by most members in our region. And as such, he is unfit to represent True Parents and their authority in front of us. Please inform True Mother that she has a very unqualified person as her representative in South America, and that he is damaging the reputation of the institution and bringing dishonor to the name of True Parents.



## Re. : Resolving the Chilean Church Problems

May our Heavenly Parent and the True Parents' blessings and love be with the South America region.

True Parents gave the heavenly command during the Second Anniversary of the Cheon II Guk Foundation Day and the 2015 Cheon II Guk Leaders' Assembly that our entire worldwide Unification movement unite and start anew. It was at that time that True Parents received a report regarding recent happenings in Chile. True Parents gave the directive that all gatherings and actions taken without the permission of the International Headquarters go against the tradition of our Unification Movement and are thus clearly invalid. True Parents have instructed everyone to follow the directives of the FFWPU International Headquarters.

Accordingly, the International Headquarters, issues the instructions listed below. We also ask that the Chile national headquarters follow the instructions given by the regional headquarters of South America and does its best to quickly restore the Chilean church to its original state.

- Build a church whose leaders and members attend True Parents as the center of their lives as well as a church that is absolutely united with the International and Regional Headquarters.
- 2) Completely stop group activities that encourage, incite or facilitate factionalism within the church.
- 3) All decisions made through meetings or gathering held without the permission of the International Headquarters are null and void.
- 4) Any course of action stemming from wrong decisions that eventually grieve True Parents' heart must be reversed.
- 5) As of February 15, 2015, all powers and authority held over church affairs by the National Leader, Raul Guzman, are revoked until further notice by the International and Regional Headquarters.
- 6) The current missionary to Chile, Ross Grange, is appointed to the position of interim national leader until an official appointment for the national leader is held under the supervision of the International and Regional Headquarters. Rev. Grange must work centering on True Parents towards healing and forging unity within members as well as restore good relationships.
