On May 20, 1948, True Father was transferred from prison in Pyongyang to a labor camp in Hungnam, an industrial city on the east coast of North Korea. There he endured a hellish existence until liberated by advancing UN forces on October 14, 1950. True Father's liberation by UN forces was by no means assured. As bombing of the Hungnam industrial complex became more intense, guards began executing prisoners, calling out their numbers starting with those having the longest sentences. In his autobiography, True Father notes, "The night before my scheduled execution the bombs fell like rain in the monsoon season ... so intense that it seemed all of Hungnam had been turned into a sea of fire. The high walls around the prison began to fall and the guards ran for their lives. Finally, the gate of the prison that had kept us in that place opened. At around two o'clock in the morning of the next day, I walked calmly out of Hungnam Prison with dignity."

Denial #2 – She claims equal authority to True Father, but she had to raise him up.

Hak Ja Han claims she had equal authority with Sun Myung Moon WHILE he was alive over all providential organizations. No member of the movement in his/her right mind would claim that her authority was equal to his during his lifetime.

Then she goes even further and claims that when they disagreed, she would RAISE HIM UP until they agreed. That's just delusional. How can she say one moment that they were equal and the next that she had to raise him up? That means she is above him and is his teacher.

Denial #3 – True Father needed marriage to her to become True Father. Without her, he had no Godly authority.

Hak Ja Han says that she understood God's thoughts at age 18 and recognized Rev. Moon as having the mission of the only begotten son. However, she says that without marrying her he could never have become the True Father. His authority only came from marrying her while her authority comes directly from God.

In truth, Sun Myung Moon came in the spirit and power of Jesus Christ. Therefore he is the long awaited Second Coming of Christ. He did not need a particular woman named Hak Ja Han. Several women were prepared by God. The woman Hak Ja Han was not necessary. If True Father's first wife had fulfilled her responsibility in that role, she would have become the True Mother and no one would have ever heard of Hak Ja Han who was a toddler at the time.

Denial #4 – True Father had to marry her and her Han lineage is superior to Moon lineage.

Hak Ja Han says clearly that she believes Sun Myung Moon became True Father only by marrying her. She also believed that the Han lineage was superior to the Moon lineage in God's providence. She never spoke of it to Preston because she knew he would disagree with her. She even admits that she never said this publicly. Obviously, she knew how it would be received by True Father.

Sun Myung Moon publicly told many people that this was false and even that he was angry that she would say/believe such a thing. She denies she ever heard him say this although many people witnessed it and the lawyer played the video.

The video from True Father's speech at the United Nations and also many testimonies of members from Las Vegas confirm that True Father talked about there being "no one in the position of his wife" or that she needed to follow or he would "divorce her." Surely she was in attendance and if not, her assistants would have reported this earth shaking statement to her.

She says she did not hear him say that he raised her up. It's clear that for many years she was not paying attention.

Every early member knows in his or her heart that the seven years after their wedding in 1960 was to raise her up because God's Day could only be established after she fulfilled certain conditions as the bride.

Denial #6 – Claiming credit for all of Sun Myung Moon's accomplishments

Hak Ja Han tries to take responsibility for everything that Sun Myung Moon accomplished, even those long before their marriage in 1960. The HSA-UWC was founded in 1954 when she was eleven years old. She believes she somehow accomplished everything True Father did. She believes that with their marriage in 1960, she could then claim she was somehow responsible for it too.

Not only that, she specifically denies that True Father was the authority in the church and claims she was "the spiritual leader from the beginning."

Before True Father passed away, no member would have said she had equal authority to True Father. No one would have said she was the spiritual leader of the church. That is especially true in their early marriage after the time of the 1960 wedding. At 18 years old, she had very little authority if any. She had to go the "servant of servants" course just like True Father did. Everyone knew about her "7 year course" when she was educated by True Father prior to establishing God's Day in 1968.

But she clearly claims that she was always THE spiritual leader in the deposition.

Hak Ja Han explains the Fall of Man was greed/self-centeredness. This is either a blatant change in the Divine Principle of Sun Myung Moon, a purposeful omission, or something else. Denial of Divine Principle #2 – Claiming a sinless birth and knowing God’s providence

Hak Ja Han believes she is the female messiah born sinless after 6,000 years. She calls herself the only begotten daughter. She believes she knew God’s heart and God’s mind, i.e. she can “fathom the divine.” At a young age she decided to ascend to the position of True Parents.

She doesn’t say how she got Rev. Moon to marry her.

This testimony is all somewhat confusing, but she seems to think she is a god or at least a goddess. She also seems to say there are two gods, male and female, although her own translator says it differently.

15:45:26 *THE WITNESS: I'm not talking about Father, Son, and Holy Spirit in Catholic religion. The wish of God -- male God and female God is to become a -- become Trinity by uniting with Parents, True Parents that are visible.*
