About the Candidates

Debra Gertz

I joined the church in 1975 in Arizona and two months later I went to Barrytown for 21 days, 40 days, 120 days workshops, then Father sent us out on God's Day 1976 to pioneer witness. I was sent to Madison, Wisconsin. Our mission was to witness and bring people (spiritual children) to the Yankee Stadium campaign before June 1, 1976, to work and attend the event. After Yankee Stadium I went to Wisconsin and Chicago to fundraise for the Washington Monument campaign and three weeks before that event I went to Philadelphia to campaign and invite people to the event and to manage and fill up a bus to go to Washington DC.

After Washington Monument I went to Madison, Wisconsin, and witnessed on campus there. A few months later I started working with one brother that had the mission to start an Il Hwa Ginseng business. From Milwaukee I went to Chicago to work with Il Hwa. Bishop Kim was our CF (he was learning English and had just came from Korea). I did Il Hwa Ginseng demos in health food stores in Chicago, then was chosen to help build, open and manage a health food store and juice bar of our own in Chicago. Our store was successful so I was sent to New York to help open the store and restaurant there on Fifth Avenue in the Tiffany building. During that mission I also did some home church work and was fortunate to be able to live in the New Yorker and to see Father every Sunday at Belvedere or at the New Yorker.

Soon after the matching in 1979, I was sent to manage the health food store in downtown Houston, Texas. I helped build up that store and won a contest (True Mother's signed picture) for having the most successful store in Il Hwa. After that I won another challenge so I got to wholesale to all the GNC stores in the Houston area and travel a bit in Texas and New Orleans to wholesale to other stores. Also at the same time I was able to train with a midwife birthing babies.

I left Houston after the Blessing in January 1983 and came to Washington, DC to get together with my husband and have been in the DC, Virginia, Maryland area since that time. We have three children, one blessed, one in the spirit world and one that was blessed but her blessing broke. We have lived in Maryland since 1988. I have had an antiques business, jewelry repair business, for about 20 years. I have been a mother, wife, and in a support position for my husband and his career.

My vision is that I hope we can understand and implement True Mother's direction and vision. I agree with her that we need to go back to teaching Divine Principle and focusing on outreach. I think I can serve the council well. I feel like we need a few more feminine voices on the council right now, and I would like to contribute and serve.

Miken Jenkins

I graduated with honors from the University of Maryland's Robert H. Smith School of Business with degrees in Accounting and Finance. I currently work as a Financial Management Consultant for the accounting firm, KPMG and am studying for exams to become a CPA (Certified Public Accountant). Before attending university, I completed three years of STF training in Europe where I took on roles ranging from team member to commander. I was blessed in 2007 to my wife Irion. We have a three-year old son, Liam.

My desire to serve on the council stems mainly from my concern for second generation. We are at a crucial point where second generation must inherit from the first generation.
