Re. : Major Decisions Made during the Third Cheon Il Guk Supreme Council Meeting

May our Heavenly Parent's and the True Parents' blessings and love be with all regions, mission nations and providential organizations.

This is to inform leaders of the major decisions made during third Cheon Il Guk Supreme Council (Moon Sun Jin: chairperson) meeting. Please make note of them.

1. Designation of agencies to represent the five Cheon Il Guk organs

- Basis: Cheon Il Guk Constitutional Addendum article 4 clause 1
- Designation of agencies for the five Cheon Il Guk organs
 - The FFWPU International Headquarters shall serve as the agency of the Cheon Jeong Won.
 - The Mission Foundation for FFWPU shall serve as the agency of the Cheon Jae Won.
 - The FFWPU-Korea Headquarters shall serve as the agency of the Cheon Gong Won.
 - ※ The Cheon Eui Won shall be installed and managed by the Cheon Eui Won Secretariat.
 - ※ The Cheon Beob Won shall be operated by the Cheon Il Guk Supreme Council Secretariat
- Function and operations of agencies
 - The agencies shall make all the necessary preparations for launching the respective organs by the authority vested in it by the Constitution.
 - If necessary, each agency may draw up and execute a budget, and may summon officials to convene a meeting, seminar, public hearing and other types of gatherings.
 - In accordance with article 33, clause 4 of the Cheon Il Guk Constitution, decisions involving important matters must be brought to the Cheon Il Guk Supreme Council for approval.

4. Tentative Road Map for the Settlement of Cheon Il Guk

- 1) By the second anniversary of Foundation Day (March 2015)
 - To assess and report on the current situation of providential organizations
 - To hold the first public hearing on the enactment of the proposed bill regarding the operations (bylaws) of the five organs of the Cheon Il Guk government.
- 2) By the third anniversary of True Father's Seonghwa (August 2015)
 - To finalize the roadmap for the operation of the five organs of the Cheon Il Guk government.
 - To hold the second public hearing on the enactment of the proposed bill regarding the operations of the five organs of Cheon Il Guk government.
- 3) By the third anniversary of Foundation Day (February 2016)
 - To promulgate bills on the operation of the five organs of the Cheon Il Guk government.
 - To appoint the executive officials of the five organs of the Cheon Il Guk government.

5. A note regarding the operation of providential organizations

- Cheon Il Guk Supreme Council members are to appointed to the board of directors of providential organizations.
 - Board of directors will be managed well and function in a rational manner.
 - Proposed sales of land or assets of a substantial size must be reported in advance.
 - Find the best way to minimize any risks when making a reinvestment.
 - Avoid accumulating excessive debts.
 - Consider ways to reduce opportunity costs in expenses and find ways to transform savings into an investment budget
 - Find efficient management methods by merging organizations or by unifying a brand that more than one organization can promote
