**INTERNATIONAL WEBINAR ON CONFLICT RELATED SEXUAL VIOLENCE IN UKRAINE**  
**THURSDAY 24 NOVEMBER AT 18:00 hours CET**

Within the framework of the support we provide to the Prosecutor General of Ukraine, the Coalition of Faith Based Organizations, the Sigmund Freud University, the Vienna Forum for Human Rights and the International Association for the Advancement of Innovative Solutions to Global Challenges, will organize an international webinar to discuss conflict related sexual violence in Ukraine. This webinar is the third in a series of events we organized, beginning with an informal consultation in May at the regional Criminal Court in Vienna and an expert meeting in October in cooperation with the University of Vienna Law School.

The goal is for participants to exchange information and share their accounts on conflict related sexual crimes committed in Ukraine. The organizers hope this event will inspire countries and organizations to provide practical effective assistance to the victims of those hideous crimes and a wake up call to bring the perpetrators to justice.
